## Job Announcement Two (2) Aquatic Invasive Species (AIS) Technicians

Golden Sands Resource Conservation & Development Council, Inc. (RC&D) is seeking **two (2)** highly motivated limited-term AIS Technicians for the summer of 2020. Employment will run from approximately May 18th through Labor Day. Each position will cover a multiple county regional area. These positions are 35 hours per week for 16 weeks. Rate of pay is \$12.00/hr. **The AIS Technicians will be expected to work most weekends throughout the season, including part of holiday weekends (Memorial Day, 4th of July, Labor Day).**

Technician responsibilities include but are not limited to: monitor for and record new aquatic invasive species, assist with aquatic plant surveys, assist with purple loosestrife biocontrol, work with volunteers on invasive species identification and removal techniques, design educational materials, distribute equipment to volunteers, conduct watercraft inspections, collect data and report on various activities.

Technicians will receive training on aquatic plant identification, aquatic invasive species identification, survey methods and proper watercraft inspection procedures. Prior experience with these topics is beneficial, but not required. Technicians must be self starters able to work independently and in a team setting. Must have good communication skills. Must be comfortable working outdoors in a variety of weather conditions. Must be comfortable working in and around water, from shore and by various watercraft.

Reliable transportation and proof of vehicle insurance is required for this position. Mileage from the primary office to the work sites will be reimbursed at the federal mileage rate.

- Position #1: Green Lake or Westfield office with focus on Waupaca, Waushara, Marquette and Green Lake Counties.
- Position #2: Stevens Point office with focus on Taylor, Lincoln, Marathon, Portage and Wood Counties.
